- Revenue Balance Ratio has increased to 3.76% of GSDP in April-August, 2020-21 from 2.91% of GSDP registered in April -August, 2019-20.
- Fiscal Balance Ratio has increased to 2.5% of GSDP in April- August, 2020-2 from 0.4% of GSDP recorded in April to August 2019-20.
- The **IPRR** (interest payments to revenue receipts) has increased to 3.9% in April-August, 2020-21 as compared to 3.6% in April August, 2019-20.
- The Debt Stock Ratio is calculated at 16.40% of GSDP in April to August, 2020-21 as against 15.68% of GSDP recorded in April August, 2019-20.
